

Description

20 Lydden Road occupies a prominent space on Lydden Road but also benefits from separate yard access via Wardley Street.

The warehouse is arranged over two bays, each with its own roller shutter door directly accessed from the secure yard. The bays are of steel portal frame construction, with brick and blockwork to the lower elevation sections and profile metal sheeting to the upper parts of the warehouse accommodation. The warehouse has a clear eaves height of 5.85m. There is a further loading door directly onto Lydden Road offering additional flexibility.

The offices are arranged over ground, first and second floors and benefit from carpeting, suspended ceilings and wall mounted radiators.

Lydden Road is accessed directly off Garrett Lane (A217), and is approximately 3.3 miles to the A3 linking with Vauxhall to the east and Kingston to the south west

The premises are within walking distance of Earlsfield Train station (1/4 mile), with services to Clapham Junction, London Waterloo, Richmond and Guildford.
